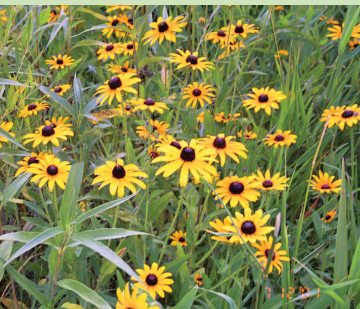




PROTECTING NORTH AMERICAN WILDLIFE

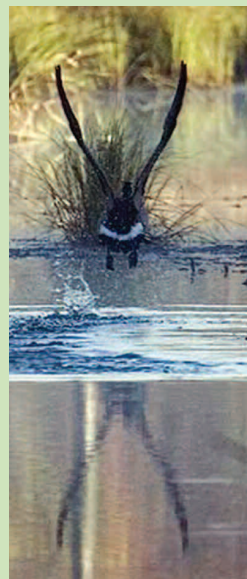
North America is home to many of the world's most impressive natural wonders, and its rich and varied habitats support a diverse range of plants and animals. The health of those environmental assets is important to everyone, and as the leading provider of waste and environmental services, Waste Management has made an ambitious commitment to preserving and protecting them:



By 2020, we're committed to have at least 100 of our facilities certified by the Wildlife Habitat Council (WHC), and to have approximately 25,000 acres of land set aside for conservation and wildlife habitat.

Today, Waste Management facilities across North America provide more than 24,000 acres of protected land for wetlands and wildlife habitat. A total of 73 Waste Management locations have received WHC's *Wildlife at Work* certification; 14 of these have also received *Corporate Lands for Learning* certification. In addition, the company was recognized in 2006 as the first organizational recipient of the Wildlife Habitat Council's President's Award, and in 2008 became the first recipient of WHC's William W. Howard C.E.O. Award, recognizing the company's efforts in conservation, education and outreach.

"WHC's work proves that corporations and advocates can work together to improve the environment," said WM CEO David Steiner. "Their recognition affirms how hard our 45,000 employees work to make a difference in our communities through sustainable conservation programs."

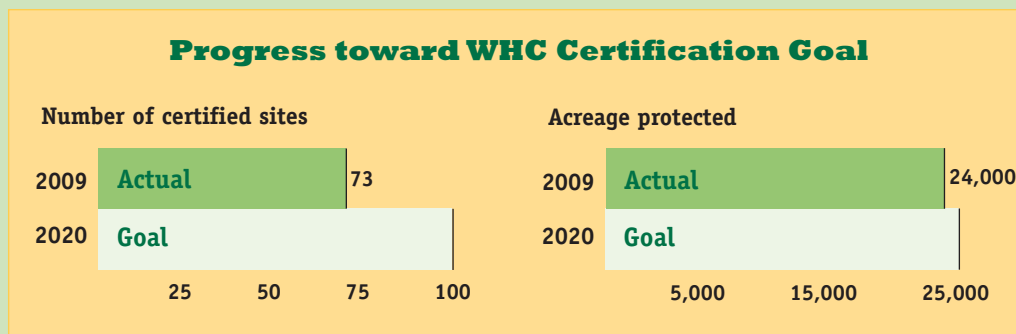

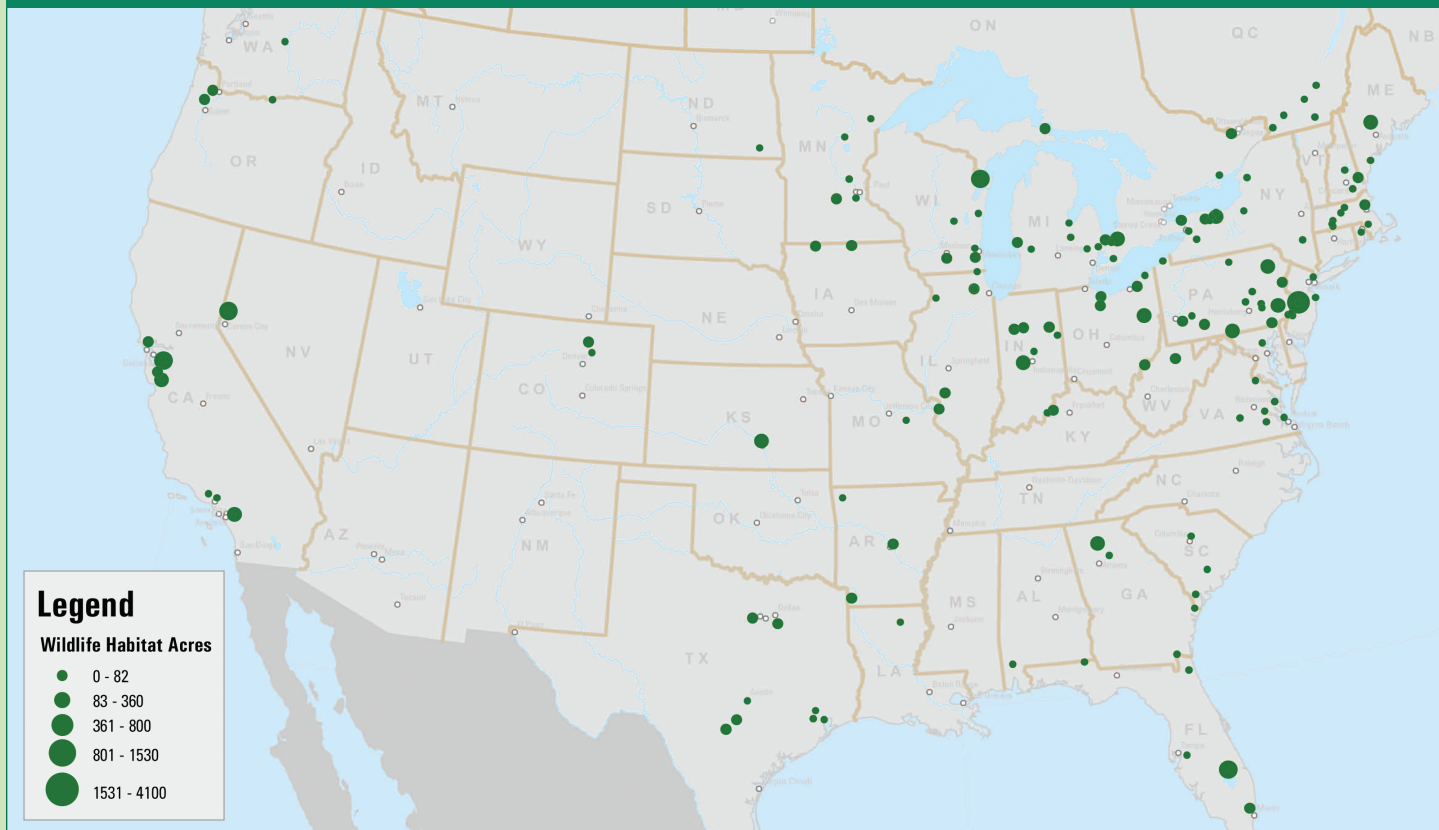
Progress toward WHC Certification Goal
