This response to your comment letter, addressed to Mr. Donald J. Smith, Texoma Market Area President, Waste Management of Texas, Inc., dated August 7, 2013, is submitted on behalf of Waste Management of Texas, Inc. The permit application for the New Boston Landfill has been revised as appropriate and one original and three copies are enclosed with this letter. Our responses to the Texas Commission on Environmental Quality (TCEQ) staff comments are presented below in the order received.

- 1. Please complete and resubmit the required TCEQ Core Data Form, consistent with the Customer name and number provided. Only one Customer Name should be associated with your permit application and one Customer Number, please correct this error to reflect the Customer Number that should be provided per applicant, also list all TCEQ Programs and ID Numbers.
- RESPONSE: The TCEQ Core Data Form has been resubmitted with Customer Number 603572132 which is consistent with the regulated entity name (New Boston Landfill) associated with the permit application and affiliated with Waste Management of Texas, Inc., the applicant and operator. As requested, TCEQ Programs and ID numbers have been identified in Section 39 of the TCEQ Core Data Form.
- 2. Please revise and resubmit the adjacent landowner's list to identify the Name of the Adjacent Landowner listed as One Ninety-eight (198) on the Adjacent Landowner's Map, or revise the map.
- RESPONSE: As requested, the Adjacent Landowner's Map has been revised to replace the reference to One Ninety-eight (198) with One Sixty-three (163).

- 3. Please revise and resubmit corrected Title Pages, removing the previous owner's name (City of New Boston), throughout the application.
- RESPONSE: The Title Pages include the names of the landfill (New Boston Landfill) and the applicant and operator (Waste Management of Texas, Inc.). There are no references to the City of New Boston on any Title Pages in the application. The City of New Boston does not have any affiliation with the facility.
- 4. The Part I Form shows that Mr. Donald J. Smith signed the property ownership affidavit for Western Waste of Texas, LLC, and the certification sheet for Waste Management of Texas, Inc. It is not clear whether Mr. Smith meets the requirements of 30 TAC §305.44 (relating to Signatories to Applications). In accordance with 30 TAC §330.59(g), please provide documentation that the person signing the application meets the requirements of 30 TAC §305.44. If the authority has been delegated, provide a copy of the document issued by the governing body of the owner or operator authorizing the person that signed the application to act as agent for the owner or operator.
- RESPONSE: Mr. Donald J. Smith is President of Western Waste of Texas, LLC and President of Waste Management of Texas, Inc. Refer to the attached affidavit which states that Mr. Smith, as the President of both Western Waste of Texas, LLC and Waste Management of Texas, Inc., is authorized to sign contracts, landfill expansion applications, regulatory filings, and other documents required for these entities to conduct business. Mr. Smith meets the requirements of 30 TAC §305.44 for the application to be signed by a responsible corporate officer. The property owner affidavit has been revised to reflect Mr. Smith's title of President of Western Waste of Texas, LLC. The certification signature page has been revised to reflect Mr. Smith's title of President of Waste Management of Texas, Inc.
- 5. In accordance with 30 TAC §330.59(e), please provide a list of all persons having over a 20% ownership in the proposed facility.
- RESPONSE: Please refer to Part I, Section 5, Page I-8 of the application. No other person owns more than 20 percent of the facility. A clarification has been added to state that no person has over 20% ownership in Western Waste of Texas, LLC (property owner) or Waste Management of Texas, Inc. (applicant and operator).
- 6. Please revise and resubmit the Table of Content page in Volume 4, Attachment E, section E5 to include a current Professional Engineer's Seal.
- RESPONSE: The Table of Contents page in Volume 4, Attachment E has been resubmitted with a current Professional Engineer's Seal for sections 5.1, 5.2 and 5.3. The content page in Appendix E5 does not require a Professional Engineer's Seal.


